When the U.S. Supreme Court rolled back long established rights, it opened the door for state legislatures to pass laws to preserve or limit those rights and judges to interpret the constitutionality of the new laws. This fall we will elect four judges to statewide office and vote on the retention of two sitting judges.

Dan McCaffrey is our candidate for Justice of the Supreme Court, Jill Beck and Timika Lane are running for Judge of the Superior Court, and Matt Wolf is running to be a Judge of the Commonwealth Court. Pennsylvania judges must stand for a retention vote every ten years. This year **Democrat Jack A. Panella**, President Judge of the Superior Court, and Republican Victor P Stabile will be on the ballot for retention.

#### Democrat Judge Candidates Outperform Republicans in Qualification Ratings by the PA Bar Association

The Judicial Evaluation Commission of the Pennsylvania Bar Association evaluates the qualifications of judicial candidates before each election. They evaluate paper submissions from the candidates and conduct personal interviews. Candidates are then rated as highly qualified, qualified, or not recommended.

For the Supreme Court, Democrat candidate **Dan McCaffrey** and his Republican opponent both received **highly qualified** ratings.

For Commonwealth Court Democrat **Matt Wolf** and his Republican opponent received **qualified** ratings.

We will elect two judges to the Superior Court. Democrats **Jill Beck** and **Timika Lane** both earned **highly qualified** ratings from the PA Bar. The two **Republican** opponents were rated **qualified** and **not recommended for failure to participate.** 

The Superior Court judges standing for retention, **Democrat Jack A. Panella** and Republican Victor P. Stabile, have both been recommended for retention by the PA Bar.

#### The PA Supreme Court Has Stopped

- efforts of Tump allies to throw out votes in Democratic Pennsylvania counties after the 2020 election
- the Republican gerrymander of PA Congressional Districts which gave Republicans an unfair majority of representatives with a minority of voters
- a Republican voter ID law which would have required people who don't have drivers licenses to go to a license center to get a picture ID, a move that makes voting harder for people who don't own cars.
